

## C128Tools 10 Year Site License

This site license is between Azalea Software, Inc. 3400 Harbor Ave SW #411, Seattle WA 98126 (AZALEA) and \_\_\_\_\_ (OUTSIDER), in which OUTSIDER agrees to license from AZALEA the **C128Tools** font package (FONTS) governed by the following terms.

FONTS is a collection of TrueType and Type 1 PostScript fonts that create **Code 128** bar codes. AZALEA will provide FONTS to OUTSIDER in either electronic format or on a CD-ROM.

FONTS may be installed on any number of computers owned by OUTSIDER. FONTS is only to be distributed in-house as a component bundled with \_\_\_\_\_ (APPLICATION). APPLICATION may be distributed among co-workers within OUTSIDER but may not be resold or distributed to others. FONTS may not be resold by OUTSIDER as a stand-alone font product.

In exchange for the limited right to distribute FONTS bundled with APPLICATION, OUTSIDER will pay AZALEA an initial licensing fee of US\$1795. Payment is due upon the signing of this license. This license is non-exclusive and in no way restricts AZALEA's right to license FONTS to others. This license is non-transferable and cannot be reassigned by OUTSIDER without AZALEA's prior written consent.

FONTS is copyright 2002 Azalea Software, Inc. This site license in no way conveys ownership of FONTS AZALEA to OUTSIDER.

OUTSIDER will include the following copyright notice in any print and/or online documentation that accompanies APPLICATION:

In the event that a problem arises with the design of one or more font characters, if OUTSIDER is unable to come to terms with AZALEA on an appropriate modification, OUTSIDER will reserve the right to modify the characters themselves. Similarly OUTSIDER will retain this right should the file structure of TrueType or Type 1 fonts undergo some fundamental change in the future.
